NEW RENEWABLE FUELS LEGISLATION INTRODUCED

The Michigan legislature has introduced a bipartisan, bicameral legislative package aimed to increase the use and production of renewable fuels in Michigan. The package will do so by offering more tools and assistance to producers, distributors and users of biodiesel and ethanol.

Based on recommendations by the Renewable Fuels Commission, this legislation will:

Provide tax exemptions for specialized equipment used to harvest biofuel-crops;

- Develop five additional agricultural Renaissance zones;
- Create a business tax credit for stations that install renewable-fuel pumps;
- Provide income tax credits and reduced sales tax for new renewable-fuel vehicles;
- Identify existing facilities that could produce renewable fuels from by-products;
- Create educational tools to encourage renewable-fuel plants to locate in Michigan;
- Allow fuel retailers to obtain renewable fuels from non-franchise distributors;
- Require the state to develop biofuel standards to improve consumer confidence;
- Expand the use of road signs to advertise renewable fuels;
- Extend the Renewable Fuels Commission until 2012;
- Create a biofuels license plate and a Renewable Fuels Fund for biofuels promotion.

"BUY MICHIGAN FIRST" INITIATIVE SUPPORTS MICHIGAN AGRICULTURE

The Michigan Department of Corrections (MDOC) recently agreed to purchase Michigan-grown potatoes for state prisons for the next four years. The contract will save the state approximately \$248,000.

In addition to the cost savings, the program boosts the Michigan economy and emphasizes the value of local farmers.

"Purchasing Michigan-grown potatoes not only saves state dollars, but also gives an economic boost to state producers and local communities," said Michigan Department of Agriculture director, Don Koivisto. "When \$1 is spent locally, that \$1 impacts three to seven different local businesses before leaving the local economy.
