Governor's Executive Order 2009-22

On Wednesday, May 13th Governor Granholm announced an Executive Order cutting over \$350 million in the current year budget. Immediately following, the Senate & House Appropriations Committee approved the Governor's Executive Order.

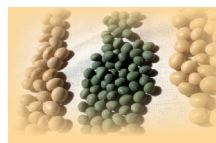
Of the cuts made, the Department of Energy, Labor & Economic Growth took the biggest hit with an 18% decrease. Others include School Aid with a 17.2% decrease and the Department of Agriculture with a 10.8% decrease.
