September 22: Interfaith Roundtable on Public Defense

On Tuesday, September 22 from 3:00 to 6:00 p.m., the Campaign for Justice is hosting an interfaith roundtable forum on public defense. The forum is being held at the Southfield Public Library, which is located at 26300 Evergreen Rd., Southfield, MI 48076. Our keynote speaker, Ann Mathews, criminal defense attorney for the Bronx Defenders, community-based public defender program in New York, will discuss how her office works not just for appropriate sentences, but to improve their clients' lives, their communities, and the safety of society as a whole.

September 23: The Campaign will be in the Upper Peninsula!

On Wednesday, September 23, from 4 to 6 p.m., the Political Science and Public Administration Department at Northern Michigan University, NMU's Student Law Forum, and the Campaign for Justice are hosting an exciting event in the Upper Peninsula. STATE FAIR LIVESTOCK AUCTION RAISES MONEY FOR MICHIGAN'S YOUTH AND SCHOLARSHIP FUND

Top bids were received for prize livestock raised by 4-H and FFA members during the annual Youth Livestock Auction on Wednesday, September 2, 2009, at the Michigan State Fair in Detroit. Michigan Department of Agriculture (MDA) Director Don Koivisto assisted on the auction floor. The 2008 youth auction gross sales were over \$69,000.

Meijer, Inc. was the top purchaser - spending over \$16,000. Binson Hospital Supplies purchased six lots totaling \$9,850. Kowalski Sausage Company and Wolverine Packing Company were also major purchasers.

Since 2000, the Michigan Youth Livestock Scholarship Fund has granted more than \$260,000 in educational awards and scholarships. The 2009 scholarship winners of \$1,500 are Shanna Acker of Middleton; Aaron Balowski of Coldwater; Justin Kennedy of Nashville; Ryan Smoes of Hamilton; and Patricia Vaassen of Ann Arbor.

Also auctioned were award-winning wines, butter, milk, and cheese. The wine basket - full of top winners from the Michigan Wine and Spirits Competition - were sold to Binson Hospital Supplies. United Dairy Industry of Michigan purchased the Grand Champion butter and milk; and the Grand Champion cheese was purchased by the Michigan Milk Producers Association.

MDA employees, participating in their 13th auction, purchased a "spotlight" market lamb, exhibited by Kelsey Sattler of Parma and a "spotlight" market hog from Kenton Klingaman of Tekonsha.
